

# Student Driver Policy



## Help for Non-English Speakers

## PURPOSE

As students reach 18 years of age, they may get their driver's license and drive to school. This policy aims to manage this to support the safety of all parties.

## SCOPE

Young drivers are one of the most vulnerable road user groups because of their inexperience, relatively underdeveloped skills and a distinct pattern of behaviour relating to youth culture and lifestyle. While most young drivers are careful, safety conscious and considerate when driving, research shows that travelling with teenage passengers constitutes an increased risk. In their first year of driving, young people are about three times more likely to be killed or injured than older, more experienced drivers.

The College has a responsibility to look at ways of improving the safety and wellbeing of our young people.

## POLICY

St Albans Secondary College is aware that a number of senior school students may intend to drive to school either occasionally or on a regular basis. It is important that all members of the school community are aware of the school policy on this matter.

Specifically:

- The College does not have space available for student parking. Consequently, no student is permitted to park their car within the College grounds
- Students are not permitted to go to their car during the school day
- It is expected that students will drive to and from school in a safe and responsible manner and adhere to road rules
- Under no circumstances can a student transport other students in their cars during school hours on school events
- If these requirements are disregarded, parents will be notified, and appropriate student sanctions will apply
- If the school becomes aware that a student driver has broken road rules or driven in an unsafe or irresponsible manner, police and parents will be notified
- Students are not to use their cars at lunchtime
- Students driving to and from school are asked to notify Year Level Coordinators and provide car & registration details

## **LETTER TO PARENT/GUARDIAN**

Dear Parent/Guardian

St Albans Secondary College is aware that a number of senior school students may intend to drive to school either occasionally or on a regular basis. It is important that all members of the school community are aware of the school policy on this matter.

Students and parents need to be aware that students cannot park in the school grounds and that they are not permitted to go to their car during the school day. It is also important that students and parents are aware that under no circumstances can students, once at school, transport other students in their cars when travelling to and from school or any school function or program. Other school expectations are detailed in the Student Driver Policy. Breaches of the school policy will lead to appropriate disciplinary action.

The school is mindful of the fact that young drivers are at greater risk than older, more experienced drivers and that travelling with teenage passengers considerably increases the risks for young drivers. Consequently, we are conscious of the need to ensure a duty of care for our students. We are also committed to ensuring that the community maintains a positive perception of the school and that irresponsible and unsafe driving by students will inevitably have a negative effect on the school's image within the community. We therefore have an expectation that students will drive to and from school in a safe and responsible manner. If the school becomes aware that students are breaking road rules, the police will be notified.
